

PROTECTION CONCEPT COVID-19 TC OBERÄGERI

In case of translation errors the German Version of the Protection Concept applies.

1. Measures clubs and tennis centers

1.1. Covid-19-Representative

Each club and tennis center must appoint a COVID-19 representative, who is available to advise the members / customers.

Measures
The COVID-19 representative for the TC Oberägeri is: Iwan Rogenmoser Riedmattli 5 6315 Oberägeri rogenmoser@mail.com 079 401 55 81
The club enters the COVID-19 representative in the Swiss Tennis member administration.

1.2. Hygiene regulations and cleaning

Compliance with the hygiene regulations of the BAG and cleaning of the facilities

Measures
Appropriate, regular cleaning of surfaces and objects after use, especially if they are touched by several people, is ensured by the following measures:
- WC's, door handles and other surfaces are regularly cleaned and disinfected
- Waste bins are collected / covered.
- Water and soap are available on the courts for cleaning hands
- Use broom only with washed hands

1.3. Social distancing

Social Distancing (2m minimum distance between all people: 10 m² per person; no physical contact)

Measures
There may be one person per 10 square meters on the system and the distance of 2 meters must be guaranteed.
Player benches or chairs are placed at a minimum distance of 2 meters.
An online system for court reservation is available.
We recommend playing mostly singles, as it is difficult to consistently keep the required distance in doubles. If the players can guarantee this at any time during an intensive game phase, they can also play doubles. Otherwise it is not advisable. This does not apply to families or people living in the same household.
The distance rules of 2m must also be ensured when entering and leaving the courts. Please do not "small talk" with people entering and leaving the courts.
Until further notice, the use of the courts is only permitted for club members (no guests or tourists).

1.4. Maximum group size & use of the facility

Maximum group size of five people according to current official requirements and the associated use of the system.

Measures
Groups of more than 5 people per court are prohibited.
The following areas are open: tennis courts and toilets
Locker rooms and showers, kitchen and Roger's Lounge remain closed (except for light and court watering system).

1.5. Logging & tracking (contact tracing)

Logging of tennis players for follow-up (contact tracing) of possible infection chains

Measures
The following measures ensure the tracking of any infection chains (contact tracing):
- Single player court reservation through online reservation system.
- Interclub teams and registered play groups (women, senior women and Rogers) report participants of the training within 24 hours by e-mail to COVID-19 representatives.
- Junior trainers log participants in the training courses and make the data available on demand from the COVID-19 representative without delay.
Remote court reservations are made possible by the following measures / systems:
- TCO online reservation system

1.6. Particularly vulnerable people and people with symptoms of illness

Particularly vulnerable people and people with symptoms of illness must observe the specific requirements of the BAG.

Measures
For your own safety, we recommend that particularly vulnerable people refrain from using the tennis facility.
Persons with symptoms of COVID-19 are prohibited from using the facilities.

1.7. Duty to provide information

Informing tennis players and other affected people about the requirements and measures.

Measures
The protective measures of TC Oberägeri were communicated to the following target groups on May 6, 2020:
The BAG poster was hung in the TC Oberägeri, and the Swiss Tennis poster "How we protect ourselves on the tennis court" was also hung.
The protection concept COVID-19 was hung up in the TC Oberägeri and sent to all members by e-mail and published on the homepage.

2. Measures tennis players

2.1 Compliance with protective measures

Acceptance and compliance with all protective measures prescribed by the club / tennis center by the tennis player

Measures
With the booked and confirmed court reservation, the member / customer accepts the defined protective measures.
The parents are responsible for ensuring that children and adolescents also fully comply with the requirements. This is ensured with the following measures:
- Communication via junior department (tennis school)

2.2 Hygiene regulations and cleaning

Compliance with the hygiene regulations of the BAG and cleaning on the system

Measures
Hands must be washed before and after playing tennis. This is ensured with the following measures:
- Water and soap are available on the site
- Water, soap and disinfectants are available in the clubhouse (when using toilet, water and / or lighting system)
- The traditional "shake hand" is dispensed with.
- No items are exchanged.

2.3 Court reservation and length of stay

Court reservation with details of personal data for tracking possible infection chains and minimum length of stay on the system

Measures
Courts must be reserved and confirmed with the personal contact details. This is ensured with the following measures:
- Court reservation for single players through the online reservation system
- Interclub teams and registered play groups (women, senior women and Rogers) report participants of the training within 24 hours by e-mail to COVID-19 representatives.
- Junior trainers log participants in the training courses and make the data available on demand from the COVID-19 representative without delay.
- Tennis players may come to the facility a maximum of 5 minutes before their playing time.
- Tennis players must have left the facility no later than 5 minutes after the end of the season.

2.4 Social distancing

Compliance with the social distancing rules on the tennis court and on the entire facility.

Measures
The social distancing rules (10 square meters per person and or minimum distance of 2 meters, no physical contact) must be observed by the tennis players at all times.

3. Measures tennis lessons

3.1. Responsibility

Acceptance and compliance with all protective measures prescribed by the club / tennis center by the tennis player

Measures
The tennis instructors assume responsibility for compliance with the protective measures defined by the club / tennis center in tennis lessons and among tennis students.
Group trainings with more than 2 tennis players plus a tennis teacher require the express permission of the board. Without further approval by the board, the use of up to 4 people plus trainer per court is permitted for the following groups:
- Junior trainings
- Interclub team training

3.2. Social distancing and maximum group size

Social distancing and maximum group size in tennis lessons

Measures
The requirements of 10 square meters per person, 2 meters and no physical contact are also ensured in tennis lessons.
There are max. 5 people allowed per court; 4 players plus coach.

3.3. Compliance with the hygiene regulations

Acceptance and compliance with all protective measures prescribed by the club / center by the tennis player

Measures
The tennis instructors observe the hygiene measures and provide sufficient hygiene products.
The handles of the ball baskets and the rest of the teaching material are regularly disinfected.

3.4. Registered trainings

Acceptance and compliance with all protective measures prescribed by the club / center by the tennis player

Measures
The training courses must be registered in the reservation system.

3.5. Customer information

Acceptance and compliance with all protective measures prescribed by the club by the tennis player

Measures
The customer is informed about all rules of conduct as follows:
